**A RESOLUTION ADOPTING THE EXECUTIVE ORDER TO BE
SIGNED BY THE CHIEF MINISTER CONSTITUTING THE
REGIONAL STEERING COMMITTEE FOR THE COMMEMORATION
OF THE 650TH ANNIVERSARY OF PHILIPPINE MUSLIM HISTORY
AND HERITAGE**

WHEREAS, the Bangsamoro Commission for the Preservation of Cultural Heritage (BCPCH) is created by virtue of Bangsamoro Autonomy Act No. 13 otherwise known as "An Act Providing for the Bangsamoro Administrative Code and Other Related Purposes" as enacted by Bangsamoro Transition Authority Parliament;

WHEREAS, Section 24, Article IX of Republic Act No. 11054, otherwise known as the "Organic Law of the Bangsamoro Autonomous Region in Muslim Mindanao (Bangsamoro Organic Law)," states that the Bangsamoro Government shall preserve the history, culture, arts, traditions, and the rich cultural heritage of the Bangsamoro people and their Sultanates, and the non-Moro Indigenous peoples of the Bangsamoro Autonomous Region;

WHEREAS, Administrative Order No. 10 issued by the President of the Philippines entitled "Constituting a National Steering Committee for the Commemoration of the 650th Anniversary of Philippine Muslim History and Heritage" provides for the designation of the BCPCH as co-vice chairperson of the *Situmiayat Wakhasum Aldikhraa* National Committee (SWANC) for the inclusive representation of the Bangsamoro Government in carrying out the National Government's commitment for the strategic implementation of programs, activities, and projects for the promotion of Philippine Muslim History and Heritage in the country;

WHEREAS, the country will commemorate the 650th Anniversary of Philippine Muslim History and Heritage beginning 2024 through 2030 in recognition of the role of Muslim Filipinos in shaping Philippine history and heritage;

WHEREAS, it is imperative to constitute a Regional Steering Committee that shall facilitate the planning and take charge of the preparations for the commemorative activities on the said commemoration rites;

NOW, THEREFORE, on motion of Commissioner Ardan D. Sali, duly seconded by Commissioner Merfa A. Ampao, **BE IT RESOLVED**, as it is hereby resolved to ADOPT THE EXECUTIVE ORDER TO BE SIGNED BY THE CHIEF MINISTER CONSTITUTING THE REGIONAL STEERING COMMITTEE FOR THE COMMEMORATION OF THE 650TH ANNIVERSARY OF PHILIPPINE MUSLIM HISTORY AND HERITAGE;
