**A RESOLUTION ADOPTING THE MEMORANDUM OF
AGREEMENT BETWEEN THE OFFICE OF THE CHIEF MINISTER
AND BANGSAMORO COMMISSION FOR THE PRESERVATION OF
CULTURAL HERITAGE ON THE APPROVED PROJECT OF
CONSTRUCTION OF TRAINING AND EXHIBITION HALL CENTER
FOR SUSTAINABILITY OF CULTURE AND HERITAGE IN LANAO
DEL SUR**

WHEREAS, the Bangsamoro Commission for the Preservation of Cultural Heritage (BCPCH) is created by virtue of Bangsamoro Autonomy Act No. 13 otherwise known as "An Act Providing for the Bangsamoro Administrative Code and Other Related Purposes" as enacted by Bangsamoro Transition Authority Parliament;

WHEREAS, Section 24, Article IX of Republic Act No. 11054, otherwise known as the "Organic Law of the Bangsamoro Autonomous Region in Muslim Mindanao (Bangsamoro Organic Law)," states that the Bangsamoro Government shall preserve the history, culture, arts, traditions, and the rich cultural heritage of the Bangsamoro people and their Sultanates, and the non-Moro Indigenous peoples of the Bangsamoro Autonomous Region;

WHEREAS, pursuant to Section 2, Article XIV of RA No. 11054, the national government shall provide a Special Development Fund (SDF) to the Bangsamoro government for the rebuilding, rehabilitation, and development of its conflict-affected communities;

WHEREAS, the Ministry of Finance and Budget, and Management (MFBM) issued Bangsamoro Budget Circular No. 2023-05 providing for the Guidelines on the Release of SDF for fiscal year 2020, 2021, and 2022;

WHEREAS, consistent with the said Budget Circular, releases from the SDF for fiscal year 2020, 2021, and 2022 shall be made directly to the appropriate implementing ministries/offices by the MFBM subject to the approval of the Chief Minister and upon submission of the Special Budget Request and the necessary supporting documents;

WHEREAS, the BCPCH, as project proponent, has an approved project under FY 2022 with an amount of Php38,000,000.00 for the Construction of Training and Exhibition Hall Center for Sustainability of Culture and Heritage in Lanao del Sur;

NOW, THEREFORE, on motion of Commissioner Elmasia L. Madjilon, duly seconded by Commissioner Merfa A. Ampao, **BE IT RESOLVED**, as it is hereby resolved to **ADOPT THE MEMORANDUM OF AGREEMENT BETWEEN THE OFFICE OF THE**
