A RESOLUTION AUTHORIZING THE INSTALLATION OF MARKERS AT THE CULTURAL PROPERTY INVENTORY OF THE MUNICIPALITY OF INDANAN, SULU

WHEREAS, the Bangsamoro Commission for the Preservation of Cultural Heritage (BCPCH) is created by virtue of Bangsamoro Autonomy Act No. 13 otherwise known as "An Act Providing for the Bangsamoro Administrative Code and Other Related Purposes" as enacted by Bangsamoro Transition Authority Parliament;

WHEREAS, Section 24, Article IX of Republic Act No. 11054, otherwise known as the "Organic Law of the Bangsamoro Autonomous Region in Muslim Mindanao (Bangsamoro Organic Law)," states that the Bangsamoro Government shall preserve the history, culture, arts, traditions, and the rich cultural heritage of the Bangsamoro people and their Sultanates, and the non-Moro Indigenous peoples of the Bangsamoro Autonomous Region;

WHEREAS, Republic Act No. 10066, or the National Cultural Heritage Act of 2009, mandates the State to protect, preserve, and promote the nation's cultural heritage, including historical sites and structures, through various initiatives, including the installation of markers;

WHEREAS, Section 11.2, Rule IV, Book II of the 2023 Implementing Rules and Begulations (IRR) of Republic Act No. 10066, the National Cultural Heritage Act of 2009, as amended by Republic Act No. 11961, and other laws and regulations on cultural heritage states that for cultural properties located within the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), the BCPCH shall have jurisdiction over these in accordance with Article IX, Section 26 of R.A. No. 11054;

WHEREAS, Section 61.4, Rule XIII, Book II of the above-mentioned IRR states that the BCPCH shall be responsible for management of Bangsamoro historical and cultural sites, and it shall coordinate with the national commission on the regulation, excavation, and preservation of cultural artifacts and on the recovery of lost historical and cultural heritage;

WHEREAS, the installation of markers at significant sites within Indanan, Sulu will serve to formally recognize and commemorate these locations, ensuring that their historical and cultural importance is preserved and communicated to both residents and visitors alike;

WHEREAS, the installation of markers is in line with the objectives of the Bangsamoro Organic Law, which underscores the need to preserve the cultural identity and historical significance of the Bangsamoro people and their ancestral domain;

RESOLVED, FURTHER, that the Commission En Banc Secretariat will coordinate with the BCPCH Coordination and Support Services Division;

RESOLVED, FINALLY, that the copy of this resolution shall be forwarded to the Office of the Sangguniang Bayan of the Municipality of Indanan, Sulu, and to the BCPCH Cultural Affairs Division;
