A RESOLUTION ADOPTING THE SANGGUNIANG BAYAN RESOLUTION NO. 27 SERIES OF 2022 OF THE ISLAMIC MUNICIPALITY OF TAMPARAN, PROVINCE OF LANAO DEL SUR ENTITLED "RESOLUTION DECLARING THE HISTORICAL SITES ASSOCIATED WITH THE BATTLE OF TAMPARAN IN 1942 AS HISTORICAL LANDMARKS OF THE ISLAMIC MUNICIPALITY OF TAMPARAN, LANAO DEL SUR"

WHEREAS, the Bangsamoro Commission for the Preservation of Cultural Heritage (BCPCH) is created by virtue of Bangsamoro Autonomy Act No. 13 otherwise known as "An Act Providing for the Bangsamoro Administrative Code and Other Related Purposes" as enacted by Bangsamoro Transition Authority Parliament;

WHEREAS, Section 24, Article IX of Republic Act No. 11054, otherwise known as the "Organic Law of the Bangsamoro Autonomous Region in Muslim Mindanao (Bangsamoro Organic Law)," states that the Bangsamoro Government shall preserve the history, culture, arts, traditions, and the rich cultural heritage of the Bangsamoro people and their Sultanates, and the non-Moro Indigenous peoples of the Bangsamoro Autonomous Region;

WHEREAS, Section 11.2, Rule IV, Book II of the 2023 Implementing Rules and Regulations (IRR) of Republic Act No. 10066, the National Cultural Heritage Act of 2009, as amended by Republic Act No. 11961, and other laws and regulations on cultural heritage states that for cultural properties located within the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), the BCPCH shall have jurisdiction over these in accordance with Article IX, Section 26 of R.A. No. 11054;

WHEREAS, Section 61.4, Rule XIII, Book II of the above-mentioned IRR states that the BCPCH shall be responsible for management of Bangsamoro historical and cultural sites, and it shall coordinate with the national commission on the regulation, excavation, and preservation of cultural artifacts and on the recovery of lost historical and cultural heritage;

WHEREAS, the Sangguniang Bayan of the Islamic Municipality of Tamparan, Lanao del Sur passed Resolution No. 27, Series of 2022 entitled "Resolution Declaring the Historical Sites Associated with the Battle of Tamparan in 1942 as Historical Landmarks of the Islamic Municipality of Tamparan, Lanao del Sur";

WHEREAS, to honor and preserve the memory of the predecessors who defended Tamparan against the Japanese Imperial Army in 1942, the Municipal Government has deemed it necessary to identify the actual historical sites that are associated with the

Battle of Tamparan, and to officially declare them as historical landmarks of the Islamic Municipality of Tamparan, Lanao del Sur;

WHEREAS, the Municipal Government has submitted for the consideration and adoption of the Body the declared historical sites associated with the Battle of Tamparan in 1942 as historical landmarks of the Islamic Municipality of Tamparan, Lanao del Sur;

WHEREAS, the said significant historical landmarks that are associated with the Battle of Tamparan in 1942 are as follows:

- (1) The old pier where the Japanese landed;
- (2) The site of the battle near the triangle intersection along the highway;
- (3) Kota Dimalawang in Brgy. Talub, Tamparan, Lanao del Sur; and
- (4) Kota Balt in Brgy. Balt Madiar, Tamparan, Lanao del Sur.

WHEREAS, the adoption of this resolution aligns with our commitment to preserving our local heritage and ensuring that these sites are accorded the protection and recognition it deserves;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, A RESOLUTION ADOPTING THE SANGGUNIANG BAYAN RESOLUTION NO. 27 SERIES OF 2022 OF THE ISLAMIC MUNICIPALITY OF TAMPARAN, PROVINCE OF LANAO DEL SUR ENTITLED "RESOLUTION DECLARING THE HISTORICAL SITES ASSOCIATED WITH THE BATTLE OF TAMPARAN IN 1942 AS HISTORICAL LANDMARKS OF THE ISLAMIC MUNICIPALITY OF TAMPARAN, LANAO DEL SUR";

RESOLVED, FURTHER, that the Commission En Banc Secretariat will coordinate with the BCPCH Coordination and Support Services Division;

RESOLVED, FINALLY, that the copy of this resolution shall be forwarded to the Office of the Sangguniang Bayan of the Islamic Municipality of Tamparan, Lanao del Sur, and to the BCPCH Cultural Affairs Division;
