A RESOLUTION ADOPTING THE SANGGUNIANG BAYAN
RESOLUTION NO. 01-2024 OF THE MUNICIPALITY OF BONGAO,
PROVINCE OF TAWI-TAWI ENTITLED "A RESOLUTION
AUTHORIZING THE INSTALLATION OF MARKERS AT
HISTORICALLY AND CULTURALLY SIGNIFICANT SITES IN
BONGAO, TAWI-TAWI"

WHEREAS, the Bangsamoro Commission for the Preservation of Cultural Heritage (BCPCH) is created by virtue of Bangsamoro Autonomy Act No. 13 otherwise known as "An Act Providing for the Bangsamoro Administrative Code and Other Related Purposes" as enacted by Bangsamoro Transition Authority Parliament;

WHEREAS, Section 24, Article IX of Republic Act No. 11054, otherwise known as the "Organic Law of the Bangsamoro Autonomous Region in Muslim Mindanao (Bangsamoro Organic Law)," states that the Bangsamoro Government shall preserve the history, culture, arts, traditions, and the rich cultural heritage of the Bangsamoro people and their Sultanates, and the non-Moro Indigenous peoples of the Bangsamoro Autonomous Region;

WHEREAS, Republic Act No. 10066, or the National Cultural Heritage Act of 2009, mandates the State to protect, preserve, and promote the nation's cultural heritage, including historical sites and structures, through various initiatives, including the installation of markers;

WHEREAS, Section 11.2, Rule IV, Book II of the 2023 Implementing Rules and Regulations (IRR) of Republic Act No. 10066, the National Cultural Heritage Act of 2009, as amended by Republic Act No. 11961, and other laws and regulations on cultural heritage states that for cultural properties located within the Bangsamoro Autonomous Region in Muslim Mindanao (BARMM), the BCPCH shall have jurisdiction over these in accordance with Article IX, Section 26 of R.A. No. 11054;

WHEREAS, Section 61.4, Rule XIII, Book II of the above-mentioned IRR states that the BCPCH shall be responsible for management of Bangsamoro historical and cultural sites, and it shall coordinate with the national commission on the regulation, excavation, and preservation of cultural artifacts and on the recovery of lost historical and cultural heritage;

WHEREAS, the installation of markers at significant sites within Tawi-Tawi will serve to formally recognize and commemorate these locations, ensuring that their historical and cultural importance is preserved and communicated to both residents and visitors alike;

- (1) Old Chinese Pier;
- (2) Spanish Garrison;
- (3) Bud Bongao Forest Park;
- (4) Bud Bongao Holy Shrines;
- (5) Luuk Banca Badjao Village;

WHEREAS, the adoption of this resolution aligns with our commitment to preserving our local heritage and ensuring that these sites are accorded the protection and recognition it deserves;

NOW, THEREFORE, BE IT RESOLVED, AS IT IS HEREBY RESOLVED, A RESOLUTION ADOPTING THE SANGGUNIANG BAYAN RESOLUTION NO. 01-2024 OF THE MUNICIPALITY OF BONGAO, PROVINCE OF TAWI-TAWI ENTITLED "A RESOLUTION AUTHORIZING THE INSTALLATION OF MARKERS AT HISTORICALLY AND CULTURALLY SIGNIFICANT SITES IN BONGAO, TAWI-TAWI";
